The undersigned ("Applicant") hereby makes this credit application ("Application") for credit to Apple Foods, Inc. ("Apple"), and in making this Application the Applicant agrees to be bound by all of the terms and conditions contained in this Application, any documents referenced by this Application and/or any supplements to this Application.

With respect to the sale of any goods by Apple to the Applicant on credit, the Applicant agrees that all amounts payable on or before the due date as shown on Apple's invoices will be paid by said due date and, if not paid on or before said due date, are then to be deemed delinquent (a "Delinquency").

If the Applicant's Application for business credit is denied, the Applicant has the right to a written statement of the specific reasons for the denial. To obtain the statement, please contact Apple's Accounts Receivable department at the address, phone and/or e-mail address shown on Page One of this form. This request must be made within 60 days from the date the Applicant is notified of Apple's decision.

Notice: *The Federal Fair Credit Opportunity Act prohibits creditors from discriminating against credit applicants on the basis of race, religion, color, national origin, sex, marital status, age (provided that the Applicant has the capacity to enter into a binding contract); because all or a part of the applicant's income derives from any public assistance program, or because the applicant has in good faith exercised any right under the Consumer Credit Protection Act. The Federal Agency that administers compliance with this law concerning this credit is the Federal Trade Commission, Division of Credit Practices, Six Pennsylvania Avenue NW, Washington, DC 20580.*

It is understood that Apple may impose and collect finance charges on any Delinquency, which charges will be the lower of (a) one and one-half percent (1-1/2%) per month or (b) the highest rate allowed by law with respect to debts due by the Applicant on any amount which becomes a Delinquency. In addition, the Applicant agrees to be liable for all internal and external collection costs and attorney's fees in connection with any Delinquency placed for collection by Apple. In the event that this Application is made by individuals or a partnership, or at any time the obligations referenced by this Application are guaranteed by individuals, the Applicant and any guarantors acknowledge and agree that any credit extended by Apple to the Applicant will be business or trade debt, and any goods provided by Apple to the Applicant on credit shall not be for personal, family or household use.

The person(s) signing this Application certifies that all of the information contained in this Application and any attachment or amendment is true, correct, and complete to the best of their information, knowledge and belief.

Attached to this Application and marked, "Customer Information Sheet" is the most current information available in response to questions on the Customer Information Sheet.

No credits will be issued without Apple's prior written approval, and all returns may be subject to a restocking charge.

All payments may be applied against open charges at Apple's sole discretion.

In the even that from time to time Apple may owe credits, refunds, reserves or other monies to the Applicant, such indebtedness shall be deemed to be created from this Agreement, and Apple shall have the right of recoupment of such credits or refunds within its sole discretion.

The Applicant acknowledges and agrees that Apple may utilize outside credit reporting services to obtain information in order to evaluate the initial credit decision and all ongoing credit decisions thereafter.

If the Applicant is an individual (Sole Proprietor) or a Partnership, the signing of this Agreement shall constitute authorization under the Fair Credit Reporting Act for Apple to utilize consumer credit reporting agencies to provide reports on said individual(s) or partners in order to permit Apple to appropriately evaluate the extension of any business credit to the Applicant.

The laws of the state of Oregon shall be applicable to all actions arising under this and any other agreement between the Applicant and Apple. All accounts shall be due and payable in Portland, Oregon. In the event of litigation, venue shall be in Portland, Oregon.
